The following are general rules for participating with the Crested Butte Mountain Sports Team. These rules are guidelines for your conduct as a CBMST athlete. As a CBMST athlete, you are expected to act in a mature and responsible manner as your actions are a reflection of yourself, your parents, coaches, and the program as a whole. Your behavior directly affects the team's reputation, standing in the community and ability to access better training opportunities and cooperation from the mountain. These rules and the rules found in the CBMST handbook must be adhered to. Any rule infraction may result in disciplinary action as set forth in the CBMST handbook.

ON-HILL POLICIES AND BEHAVIOR

1. Remember, we are ambassadors for the area, and we need to act as such at all times. Please show respect for your coaches, teammates, public skiers, and employees of Crested Butte Mountain Resort.
2. Foul language on the hill or in the club room is unacceptable. Directing profanity towards your teammates or Coaches directly or indirectly, on-hill or off, will be taken very seriously and will be dealt with accordingly.
3. All athletes will arrive at training with a good positive attitude. Athletes will be expected to be attentive and energetic or they will not be welcome to train.
4. Always carry your season pass.
5. Be courteous when presenting your ski pass at all resorts. The lift attendant is simply doing their job!
6. Obey the skier's responsibility code. The general public comes first at all resorts. Typically you will be the better skier or rider, be respectful to those learning the sports we all know and love.
7. No tucking on any slope unless we are training and are supervised by a coach.
8. Lift line privileges will be managed only by the staff when applicable. i.e. No coach, no line cutting.
9. If public skiers run one of our courses, do not yell at them; politely ask them to refrain from doing so and explain what the course is for. If you have a problem, find a coach.
10. Athletes should present themselves with an appropriate Athletic demeanor.
11. In case of emergency, call the ski patrol **349-2236** or go to a lift attendant for assistance.

TRAINING ATTIRE:

1. Helmets must be worn at all times and fastened correctly.
2. Training attire is different for every sport. Please check with your Head Coach during the first weeks of training to find out what is expected of the athletes.

EQUIPMENT

Equipment needs vary by sport and level. Please check with your head coach in the fall to find out what will be expected for the athletes individual needs.

Your equipment is your responsibility. Take an active interest in learning proper tuning techniques. By the time you are a 13, you should be able to maintain your skis/board without the help of your coaches or parents.

ACADEMIC ELIGIBILITY

School work is equally important, if not more so, as competing in sports.

1. Each student athlete must maintain at least a cumulative "C"(70%) in each class for a given semester in order to continue to train and compete with CBMST. If acceptable grades are not maintained at all times, the privilege of training and racing may be taken away. Please refer to the CBCS- CBMST Cooperative Program and the CBCS Student Athletic Handbook for more details. We cannot stress the importance of this enough!
2. It is the athlete's responsibility to inform and communicate completely, well in advance (2 week min.), with their teachers prior to absence from class for any races or special training where they will be absent from school.
3. It is the athlete's responsibility to make up missed assignments and/or find a tutor if needed.

TEAM ROOM AND OFFICE

1. Please be respectful of all locker room space.
2. Every day one team will be responsible for locker room clean up.
3. Wrestling, snowball throwing, pole fights, name calling and roughhousing will not be tolerated in the team room or elsewhere.
4. The team and coaches' offices are off-limits unless invited.
5. Tuning benches are there for everyone's use. Please clean up after yourself.
6. Hard goods can be stored in locker room overnight. Soft goods and boots must return home with the athletes daily.
7. CBMST is not responsible for lost tuning supplies or equipment.
8. Borrowing other teammates' equipment without permission will be treated as stealing.
9. Only the coaching staff may use video equipment, cameras, drills, etc.
10. If eating lunch in the building, athletes are responsible for cleaning up after themselves.
11. Drugs of any kind are illegal and their use is prohibited by CBMST members. Alcohol, marijuana, illegal drugs and tobacco are illegal for those under the age of 21, and their use is strictly prohibited. CBMST will enforce these laws and will contact the police if we find anyone breaking these laws. This includes traveling for competitions and training.
12. No pets are allowed in the building, team room, or on the hill.

PENALTIES FOR RULE INFRACTIONS

CBMST will enforce the above code of conduct. Any disrespect or disregard for these rules will be met with serious consequences.

1. Infraction 1: Dismissal from practice for the day.
2. Infraction 2: Suspension from practice and races for the week.
3. Infraction 3: Release from the team with NO MONETARY COMPENSATION.

CBMST Travel Guidelines

Please review these guidelines to make yourself aware of CBMST travel policies.

Any athlete competing at an event – even if they do not travel with the team or stay with the team – will be required to share in the cost of the coach's travel expenses (team gas & food) and must fill out a credit card authorization sheet prior to the trip's departure. These costs are not included in your programs tuition and are additional costs.

- Athletes must have notified all of their teachers a minimum of 2 week in advance and provide them with a tentative schedule for the season ASAP. School work missed should be done during the trip or prior to and the students should not request extra time to complete assignments.
 - Athletes may be charged a coaching fee for the difference of the days of the trip and the days of programming they have enrolled for. (i.e. A 1 day athlete goes on a 3 day trip they will be billed for the additional 2 days of coaching while on the trip.)
 - Any athlete under the age of 13 must be accompanied by a parent or guardian.
 - Athletes must be invited/approved by the attending coach in order to travel with the team and/or attend the competition as a CBMST athlete.
 - A trip summary and expense work sheet will be provided for the away competition 14 days prior to the event.
 - The trip roster will be finalized 5 days prior to departure. Any changes in the roster after 5 days will result in a minimum \$50 fee or more depending on the expenses and circumstances of the trip.

1. Be on time for all departures.
 2. Have your equipment ready prior to departure. Make a check list!
 3. Assist in loading, unloading and cleaning the team vehicles.
 4. Ensure that all entry fees are paid in advance and athletes are provided adequate funds for incidental costs such as lift tickets, food, etc...
 5. Travel and lodge with CBMST coaches during out-of-town events, unless otherwise approved and pre-arranged.
 6. Respect boundaries - no boys in girls' rooms and no girls in boys' rooms unless supervised by a coach or parent.
 7. Follow curfew restrictions designated by coaches and all other *Athlete code of conduct rules*.

- CBMST will do everything possible to supply adequate transportation to away competitions, but due to schedules of other disciplines and number of athletes attending this may not always be possible.
 - Failure to adhere to any of these guidelines may result in travel suspension and/or training suspension.

**Mountain Sports Team WARNING, ASSUMPTION OF RISK, RELEASE OF LIABILITY &
INDEMNIFICATION AGREEMENT**

**PLEASE READ CAREFULLY BEFORE SIGNING. THIS IS A RELEASE OF LIABILITY & WAIVER OF
LEGAL RIGHTS.**

1. Definitions. The person who is participating in the Mountain Sports Team shall be referred to hereinafter as "Participant". The "Undersigned" means only the Participant when the Participant is age 18 or older OR it means both the Participant and the Participant's parent or legal guardian when the Participant is under the age of 18. "Released Parties" mean Crested Butte, LLC, Triple Peaks, LLC, Resort Asset Management, LLC or any of their respective successors in interest, affiliated organizations and companies, insurance carriers, agents, employees, representatives, assignees, officers, directors, members, and shareholders; and the U.S. Forest Service. The "Activity" means taking part in the Mountain Sports Team, competitions, skiing, snowboarding, training, and using the ski area facilities including the lifts, for any purpose.

2. Risks of Activity. The Undersigned agree and understand that taking part in the Activity can be HAZARDOUS AND INVOLVES THE RISK OF PHYSICAL INJURY AND/OR DEATH. The Undersigned acknowledge that the Activity is inherently dangerous and fully realize the dangers of participating in the Activity. The risks and dangers of the activity include, but are not limited to: falling; slick or uneven surfaces; surface and subsurface snow conditions; bumps; moguls; ice; variations in terrain; rugged mountainous terrain; downed timber; stumps; forest growth; rocks; debris; marked and unmarked obstacles; man-made objects; lift towers; terrain park features and elements; visibility; collisions; encounters with snowmobiles and/or other motor vehicles; lift loading, unloading, and riding; adverse weather; avalanches; limited access to and/or delay of medical attention; fatigue; exhaustion; dehydration; hypothermia; high elevation; altitude sickness; frostbite; mental distress from exposure to any of the above; and negligence of others. THE UNDERSIGNED ACKNOWLEDGE AND UNDERSTAND THAT THE DESCRIPTION OF THE RISKS LISTED ABOVE IS NOT COMPLETE AND THAT PARTICIPATING IN THE ACTIVITY MAY BE DANGEROUS AND MAY INCLUDE OTHER RISKS.

3. Duties of Participant. The Participant assumes the responsibility of maintaining control at all times while engaging in the Activity. Participant is responsible for reading, understanding and complying with all signage, including instructions on use of lifts. Participant must have the physical dexterity and knowledge to safely load, ride and unload the lifts. Participant acknowledges that he/she has the physical dexterity and knowledge to safely load, ride, and unload the lifts. Participant assumes the risks of riding the lifts and engaging in activities accessible from the lifts. Further, the Undersigned understand that a minor Participant may use the ski lifts without an adult present. Participant acknowledges that snowmobiles, snowmaking, snow-grooming equipment and/or other motor vehicles and equipment may be encountered at any time. Participant understands that entering or skiing in a "CLOSED" area is illegal.

4. Release, Indemnification, and Assumption of Risk. In consideration of the Participant being permitted to participate in the activity, the Undersigned agree as follows:

(a) Release. THE UNDERSIGNED HEREBY IRREVOCABLY AND UNCONDITIONALLY RELEASE, FOREVER DISCHARGE, AND AGREE NOT TO SUE OR BRING ANY OTHER LEGAL ACTION AGAINST THE RELEASED PARTIES with respect to any and all claims and causes of action of any nature whether currently known or unknown, which the Undersigned, or any of them, have or which could be asserted on behalf of the Undersigned in connection with the Participant's participation in the Activity, including, but not limited to claims of negligence, breach of warranty, and/or breach of contract.

(b) Indemnification. The Undersigned hereby agree to indemnify, defend and hold harmless the Released Parties from and against any and all liability, cost, expense or damage of any kind or nature whatsoever and from any suits, claims or demands, including legal fees and expenses whether or not in litigation, arising out of, or related to, Participant's participation in the Activity. Such obligation on the part of the Undersigned shall survive the period of the Participant's participation in the Activity.

(c) Assumption of Risk. The Undersigned agree and understand that there are dangers and risks associated with the participation in the Activity and that INJURIES AND/OR DEATH may result from participating in the Activity, including, but not limited to the acts, omissions, representations, carelessness, and

negligence of the Released Parties. By signing this document, the Undersigned recognize that property loss, injury and death are all possible while participating in the Activity. RECOGNIZING THE RISKS AND DANGERS, THE UNDERSIGNED UNDERSTAND THE NATURE OF THE ACTIVITY AND VOLUNTARILY CHOOSE FOR PARTICIPANT TO PARTICIPATE IN AND EXPRESSLY ASSUME ALL RISKS AND DANGERS OF THE PARTICIPATION IN THE ACTIVITY, WHETHER OR NOT DESCRIBED ABOVE, KNOWN OR UNKNOWN, INHERENT, OR OTHERWISE.

5. Minor Acknowledgment. In the case of a minor Participant, the Undersigned parent or legal guardian acknowledges that he/she is not only signing this Agreement on his/her behalf, but that he/she is also signing on behalf of the minor and that the minor shall be bound by all the terms of this Agreement. Additionally, by signing this Agreement as the parent or legal guardian of a minor, the parent or legal guardian understands that he/she is also waiving rights on behalf of the minor that the minor otherwise may have. The Undersigned parent or legal guardian agrees that, but for the foregoing, the minor would not be permitted to participate in the Activity. By signing this Agreement without a parent or legal guardian's signature, Participant, under penalty of fraud, represents that he/she is at least 18 years of age. If signing as the parent or guardian of a minor Participant, signing adults represent that they are a legal parent or guardian of the minor Participant.

6. Medical Care. Undersigned authorize the Released Parties and/or their authorized personnel to call for medical care for Participant or to transport Participant to a medical facility or hospital if, in the opinion of such personnel, medical attention is needed. Undersigned agree to pay all costs associated with such medical care and related transportation.

7. Photo Release. THE UNDERSIGNED irrevocably grant Crested Butte Mountain Resort the right of publicity to own and use without compensation any image(s) collected of the Participant while participating in the Activity.

8. Miscellaneous. The Undersigned further agree and understand: (a) Participant will not engage in any activities prohibited by any applicable laws, statutes, regulations and ordinances; (b) this Agreement shall be governed by the laws of the State of Colorado, and the exclusive jurisdiction for any claim shall be the District Court of Gunnison County, Colorado or the federal court of the State of Colorado; (c) this Agreement constitutes the entire agreement between the parties hereto and supersedes any and all prior contracts, arrangements, communications, or representations, whether oral or written, between the parties relating to the subject matter hereof; (d) the Undersigned understand and acknowledge that this Agreement is a contract and shall be binding to the fullest extent permitted by law. If any part of this Agreement is deemed to be unenforceable, the remaining terms shall be an enforceable contract between the parties. It is the intent of the Undersigneds that this agreement shall be binding upon the assignees, subrogors, distributors, heirs, next of kin, executors and personal representatives of the Undersigned. THE UNDERSIGNED agree and understand that **THIS RELEASE IS APPLICABLE TO EACH AND EVERY DAY PARTICIPANT PARTICIPATES IN THE ACTIVITY FOR THE 2016/2017 SKI SEASON.**
